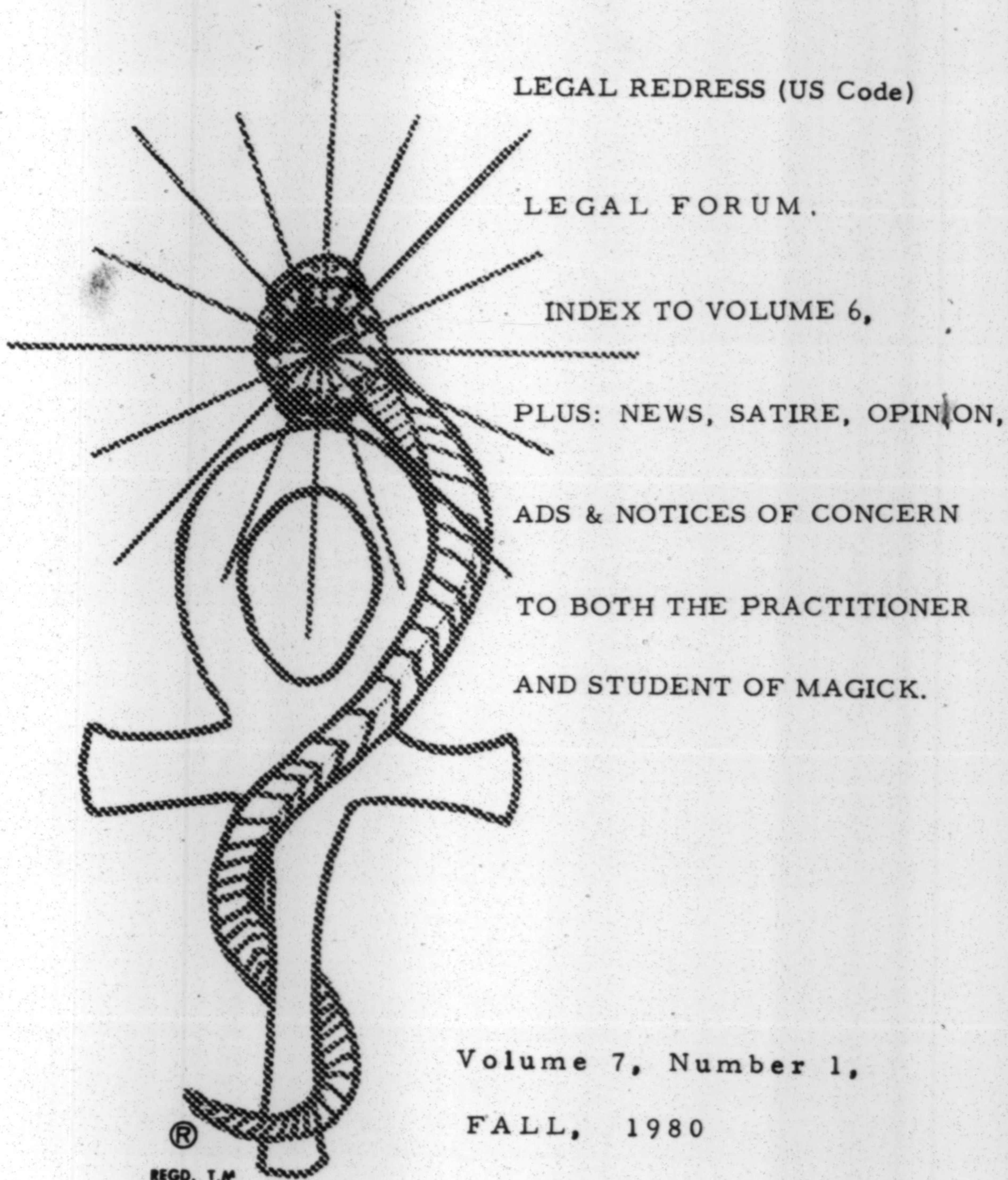

LEGAL REDRESS  
Access to the Federal Courts  
By: Rev. Nelson H. White, D.D.

42 USC 1983

"Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory, Subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress."

18 USC 241

CONSPIRACY AGAINST RIGHTS OF CITIZENS:

"If two or more persons conspire to injure, oppress, threaten, or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or

If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured --

They shall be fined not more than \$10,000 or imprisoned not more than ten years, or both; and if death results, they shall be subject to imprisonment for any term of years or for life."

18 USC 242

DEPRIVATION OF RIGHTS UNDER COLOR OF LAW:

"Whomever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any inhabitant of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such inhabitant being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined not more than \$1,000 or imprisoned not more than one year, or both; and if death results shall be subject to imprisonment for any term of years or for life."

As many Occultists have no "feel" for things legal, and in fact may be scared to death of the word "Lawyer", we have presented the above Federal Statutes verbatim, for your information and use.

Most people are ignorant when it comes to Federal Law and issues such as Civil Rights. Very little of this sort is taught in the schools these days, and much of what is taught is incorrect.

The first, (42 U.S. Code, 1983) is the most important to the Occultist. This statute gives you the right to sue for damages in Federal Court, and by inference, State Courts as well. The statute is important because it gives you a specific right to sue any "person". This includes Peace Officers, Governmental Officials and Governments themselves (because an Incorporated City or County is a "person") and conventional business Corporations.

One of the big advantages in Federal Suits, is that if there is a Constitutional question involved, the Government may bring the action for you, at no cost to you.

In future issues of TWL we will discuss the various methods of bringing suits including the method that is (almost) cost free.

We realize that all this going on about legal matters is not "Magickal". We do this because there are many pitfalls in the simple practice of the religion of your choice, and no other Occult publication has made any attempt to inform you, the Magickal Student in this area.

## Sperm Bank Draws Criticism, 'A Moderately Expensive Hobby' For Wealthy California Businessman

Earlier this spring, the Los Angeles Times reported that 74-year-old Robert K. Graham, a wealthy California businessman, had established an exclusive sperm bank for Nobel Prize winners. It was called the Hermann J. Muller Repository for Germinal Choice, named after Graham's late friend and Nobel Prize winner in Physiology.

The idea was really quite simple. Several years ago Graham began writing to Nobel laureates asking for sperm donations. Thus far five are known to have complied.

The sperm is frozen and stored in his subterranean sperm bank built on a ten-acre estate in Escondido, Calif. Then Graham, a member of Mensa (a group of 33,000 people with very high IQ's) announced last summer in the Mensa Bulletin that he was looking for bright women, under 35 and preferably married to a sterile man, who would volunteer to become impregnated with the Nobel sperm. Dozens of women applied.

To date, three such women, all on the east coast, have indeed become pregnant of Graham's Nobel donor program. The women must agree to send Graham regular reports of their pregnancy and, after the child is born, on the health and IQ of the infant. Says Graham, "This is just the beginning."

Graham's intent (he calls it a "moderately expensive hobby") is that freezing gifted men's sperm for later insemination of bright women will improve the genetic stock of the human race. In criticizing this procedure, Stanford University professor Burton Richter, who won the Nobel Prize for Physics in 1976, says, "What they are trying to do is create an intellectual superman, and selecting winning Nobel Prize scientists is not the way to do it."

### "Plain" Sects Win Photo Exemption

HARRISBURG, Pennsylvania—Members of the Mennonite and other "plain" religious sects will not need to have their photos taken for Pennsylvania's new drivers' licenses.

While many groups forbid members to use automobiles, others permit it, the Pennsylvania Transportation Department was told by constituents who hold religious scruples against posing for photographs because they regard it as an act of vanity.

A transportation department spokesman said a regulation permitting exemption for religious reasons was being prepared for adoption.

Thus far only one Nobel donor has revealed himself. He is William Shockley, the prize winner in physics, 1956, who's genetic opinions are frequently labeled as racist.

Shockley comments, "I don't regard myself as a perfect human being or the ideal candidate, but I am endorsing Graham's concept of increasing the people at the top of the population."

"The principles of this may not be popular," admits Graham who notes that until now "we have refused to apply to humans what we already know and apply to animals and plants."

Graham obviously underestimated the unpopularity of his principles. Although he made his repository for germinal choice known last summer, it was not until March of this year that the Times broke the story and a flood of response began.

### Judge Enjoins Praying in School

ALBANY, New York—A group of suburban Guiderland High School students have been denied permission by a federal judge to hold a prayer meeting on school premises before classes each morning.

U.S. District Court Judge Neal McCurn, of Syracuse, who dismissed the suit by six students, said that while he was "not comfortable with the result in this case," the prayer meetings would violate the First Amendment provision for separation of church and state.

Robert Roche, the students' attorney, said he would recommend to the Milwaukee-based National Catholic League of Religious and Civil Rights that an appeal be filed. The league backed the students' action and paid the court fees.

### Moonies Denied Permits

KEENE, New Hampshire—The Keene City Council has voted 12 to 1 not to allow Unification Church followers of the Reverend Sun Myung Moon to solicit funds door to door.

The church members had sought permission to sell silk flowers and other items on a three-day weekend in the near future. Keene Mayor Richard P. Pelouin had argued against the proposal, saying that the church members had been in Keene before and had proved a nuisance.

### Atheist Scores Telling Point

AUSTIN, Texas—Madalyn Murray O'Hair has asserted that all Texas judges are unfit to preside over her trial (on charges of disrupting a public meeting) because she is an atheist and state law requires them to believe in a supreme being.

Mrs. O'Hair asked County Court Judge Brock Jones to disqualify himself. She also said she would seek a similar motion against any other judge named to hear the case.

Judge Jones said he would ask court officials to appoint another judge to rule on Mrs. O'Hair's motion.

### Mormon Fundamentalist's Widow Files \$72 Million Damage Suit

SALT LAKE CITY—The widow of excommunicated Mormon fundamentalist John Singer, who was shot to death last year by a sheriff's deputy, has filed a wrongful-death lawsuit against Utah officials, seeking damages of \$72 million.

Among defendants named in the suit filed in Federal District Court by Vicky Singer are the governor of Utah, the attorney general, the Summit County sheriff, and the head of the State Department of Public Safety.

Mr. Singer, 47, a Summit County farmer and polygamist who was excommunicated some seven years ago by the Church of Jesus Christ of Latter-day Saints (Mormon), was killed in January, 1979, during a sheriff's raid.

The incident grew out of a six-year controversy between Singer and Summit County officials over his right to educate his ten children at home. He withdrew his school-age children from the public schools in 1973 because of objections to "evil influences" in modern education. The county pressed charges against him when he refused to allow school board progress tests for the children.

Relations between Singer and county officials worsened, with rising suspicion and aggravation on both sides. Singer began carrying firearms and was said to be waving his gun when shot by an officer during the sheriff's raid, after several unsuccessful attempts to arrest him.

Vicky Singer's suit raises the First Amendment issue of religious freedom and the question of whether a non-Mormon can get fair treatment in Mormon Church-dominated Utah.

Mr. Singer, a Mormon convert, was excommunicated by the church, reportedly for constantly questioning church doctrine. His legal problems increased with his announcement in October, 1978, that he had taken a second wife and performed the ceremony himself.

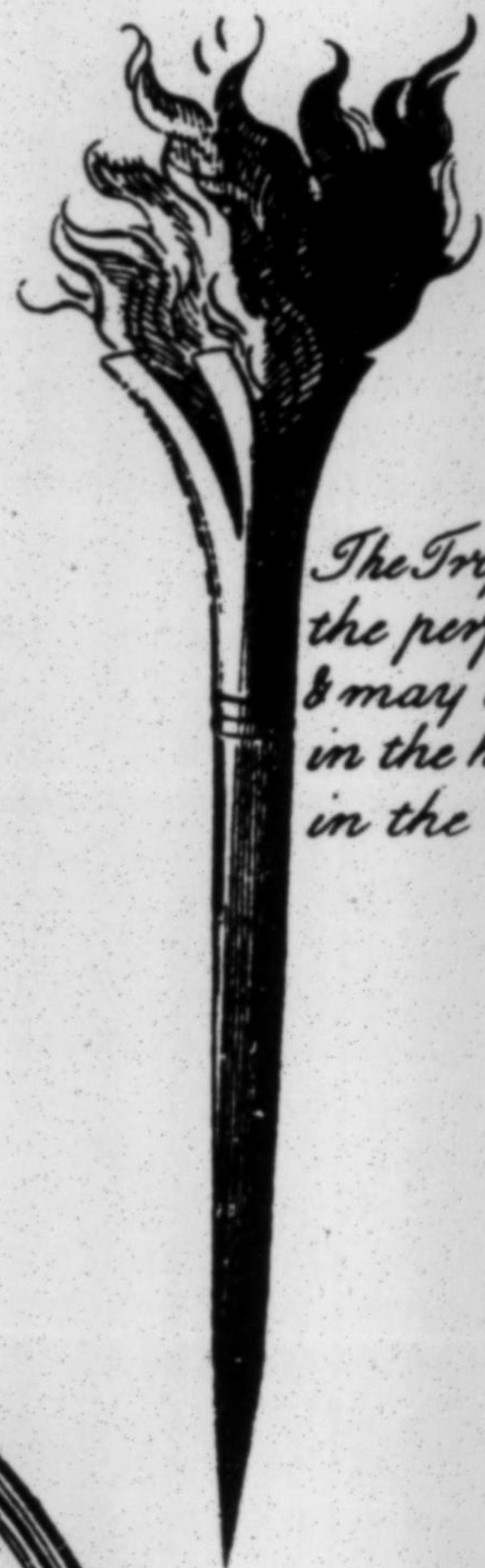
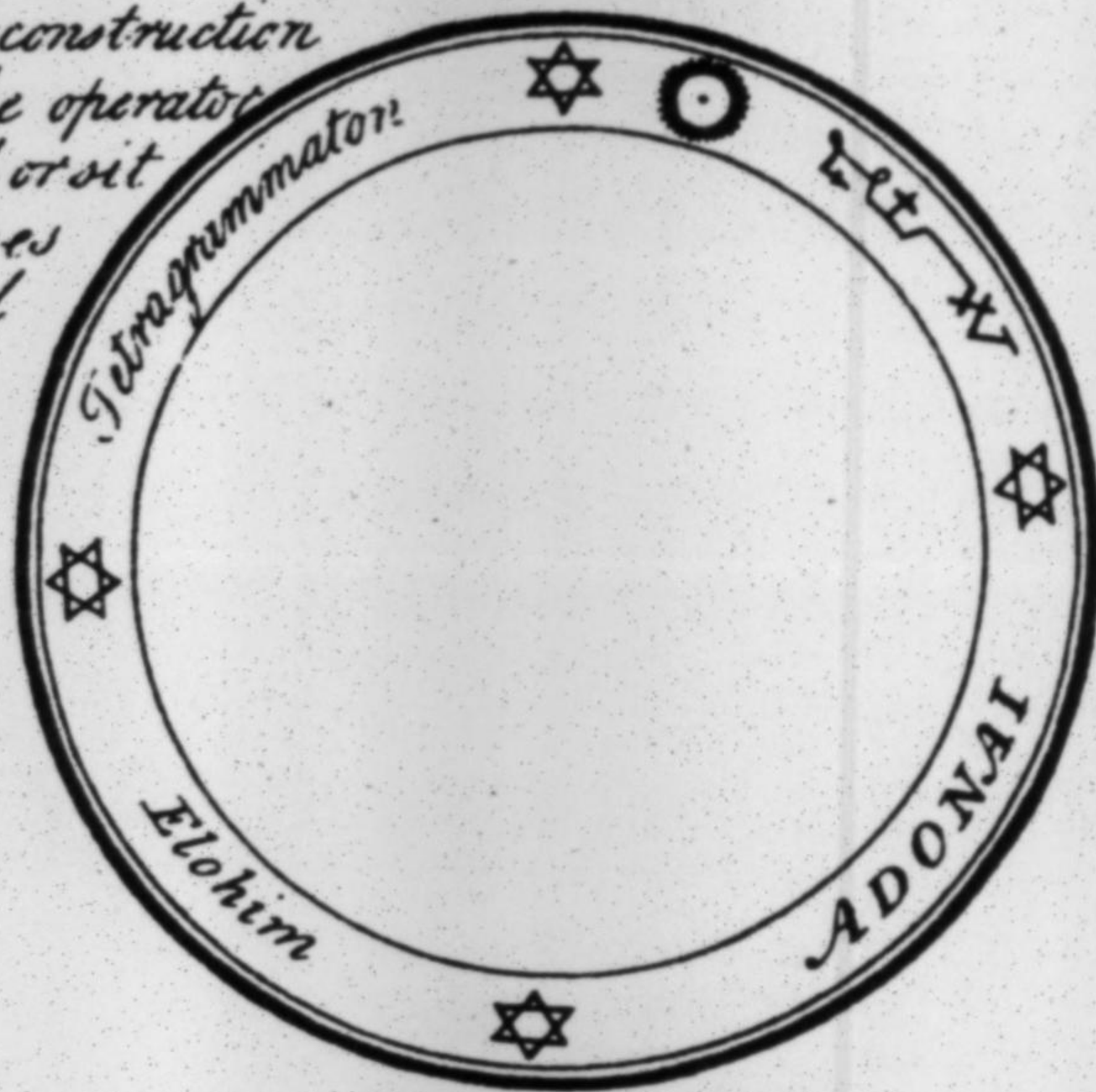

#### LEGISLATIVE COUNSEL'S DIGEST

SB 1493, as amended, Petris. Corporations.

Under existing law, the Attorney General is empowered to  
examine religious corporations in specified instances, and to  
institute an action in the name of the state to correct wrongful  
activity, or to seek an order establishing that the corporation  
fails to qualify as a religious corporation.

This bill would repeal existing law and instead provide that  
*except as the Attorney General is empowered to act in the  
enforcement of the criminal laws of this state and except as  
specifically empowered by this bill*, the Attorney General  
shall have no powers ~~relating to any subject or matter covered  
by the Nonprofit Religious Corporation Law~~ with respect to  
any corporation incorporated or classified as a religious  
corporation ~~except as specifically provided by the bill~~.

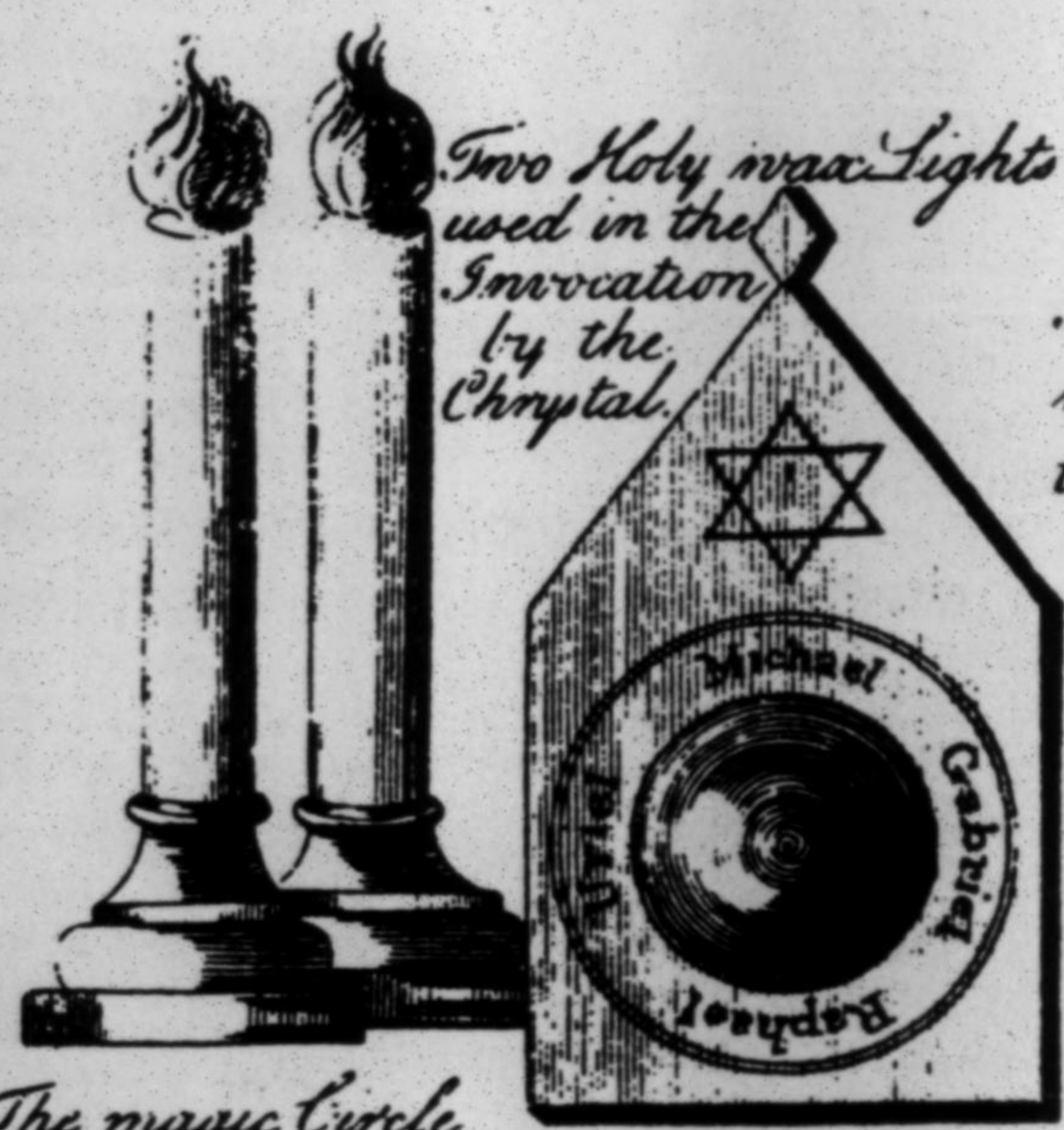

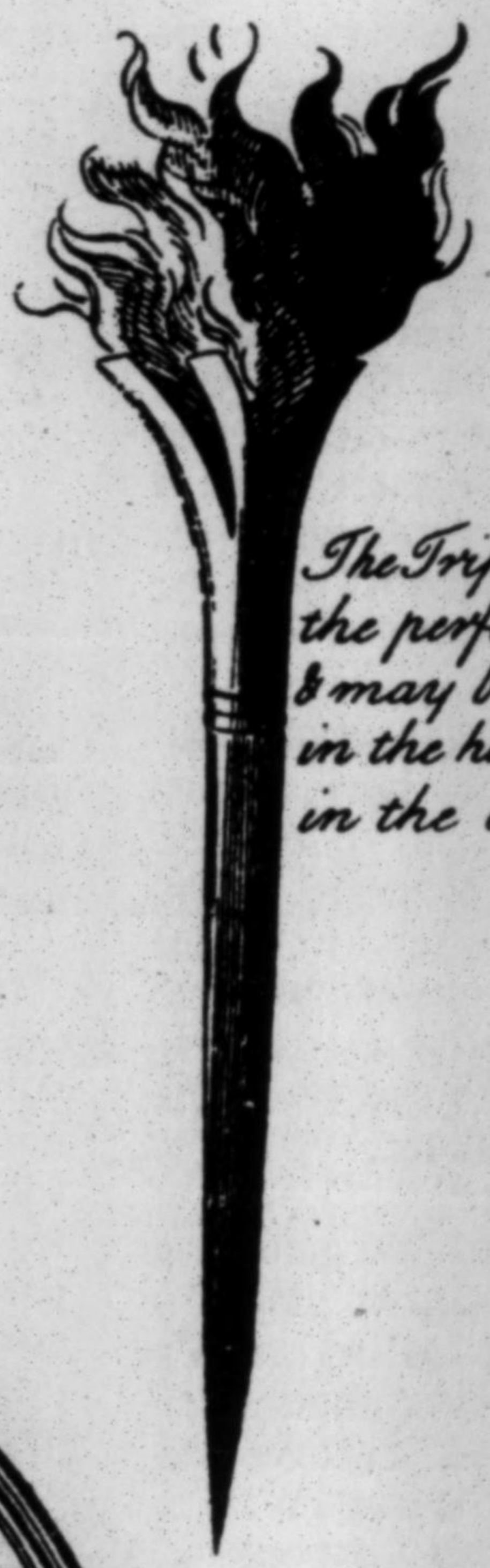
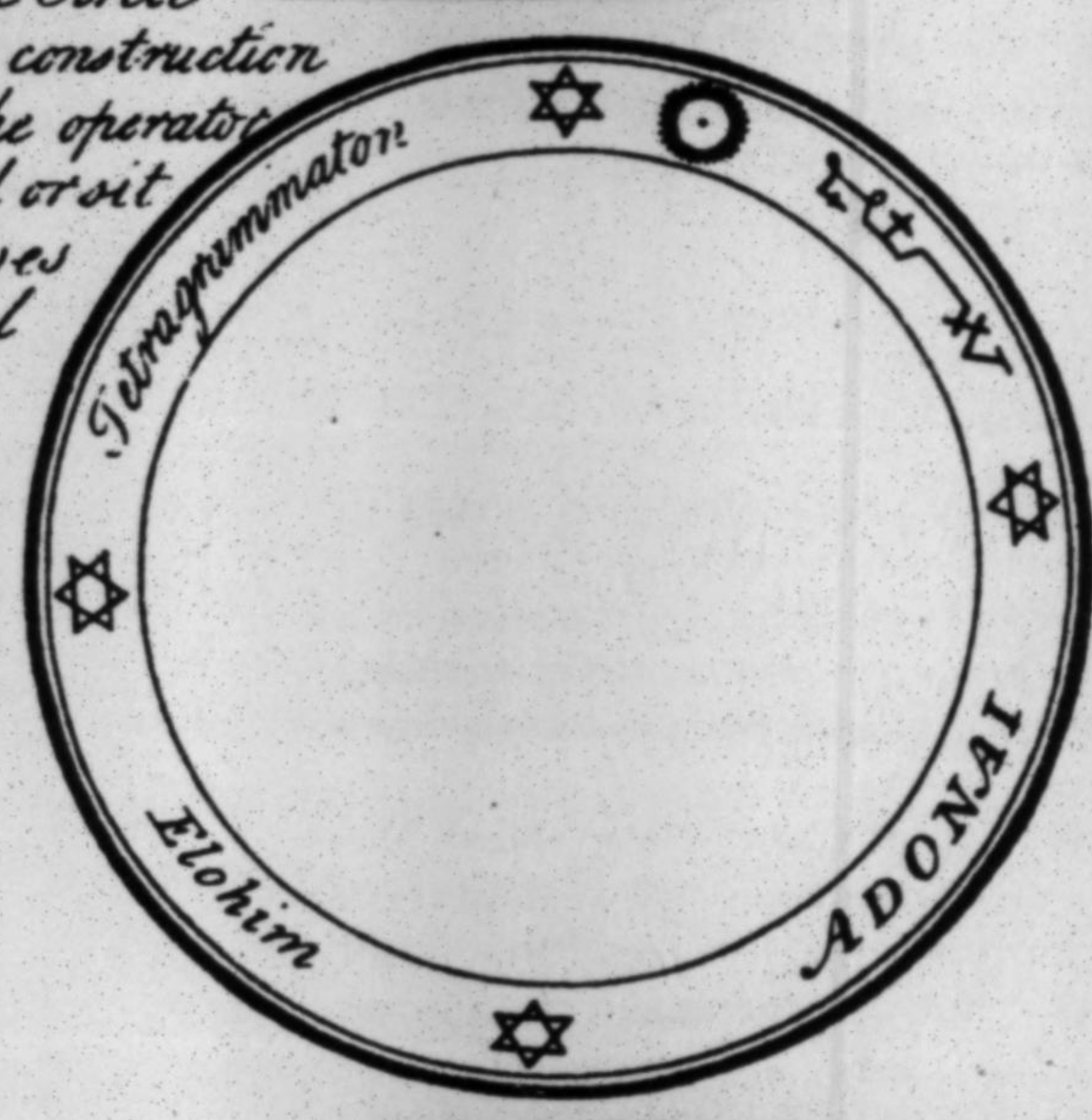

#### LEGISLATIVE COUNSEL'S DIGEST

SB 1493, as amended, Petris. Corporations.

Under existing law, the Attorney General is empowered to examine religious corporations in specified instances, and to institute an action in the name of the state to correct wrongful activity, or to seek an order establishing that the corporation fails to qualify as a religious corporation.

This bill would repeal existing law and instead provide that *except as the Attorney General is empowered to act in the enforcement of the criminal laws of this state and except as specifically empowered by this bill*, the Attorney General shall have no powers relating to any subject or matter covered by the Nonprofit Religious Corporation Law with respect to any corporation incorporated or classified as a religious corporation *except as specifically provided by the bill*.

The New York Legislature recently enacted a law mandating a minimum prison sentence of one year for carrying a loaded handgun in a public place without a license, even if one hasn't committed a crime!

Very few persons in New York City, for example, are allowed to possess a firearm *even when* all conditions for licensing are met. *The people of the State of California do enact as follows:*

1 SECTION 1. The Legislature finds and declares that  
2 the First Amendment to the Constitution of the United  
3 States, and Article I, Section 4 of the California  
4 Constitution provide that Congress and the California  
5 Legislature shall make no law respecting an  
6 establishment of religion or respecting the free exercise  
7 thereof. The special protection afforded to freedom of  
8 worship, freedom of conscience, and freedom of thought  
9 lie at the very core of the American heritage and  
10 American freedoms, and bitter experience in lands which  
11 afforded no such protections led to the birth of an  
12 American republic committed to freedom of religion.  
13 Such protections and heritage require that government  
14 action regarding religious bodies must be narrow and  
15 minimal. The Legislature hereby declares that the power  
16 of the State of California with respect to the formation,  
17 existence, and operation of religious corporations shall be  
18 limited to those expressly provided in statutes duly

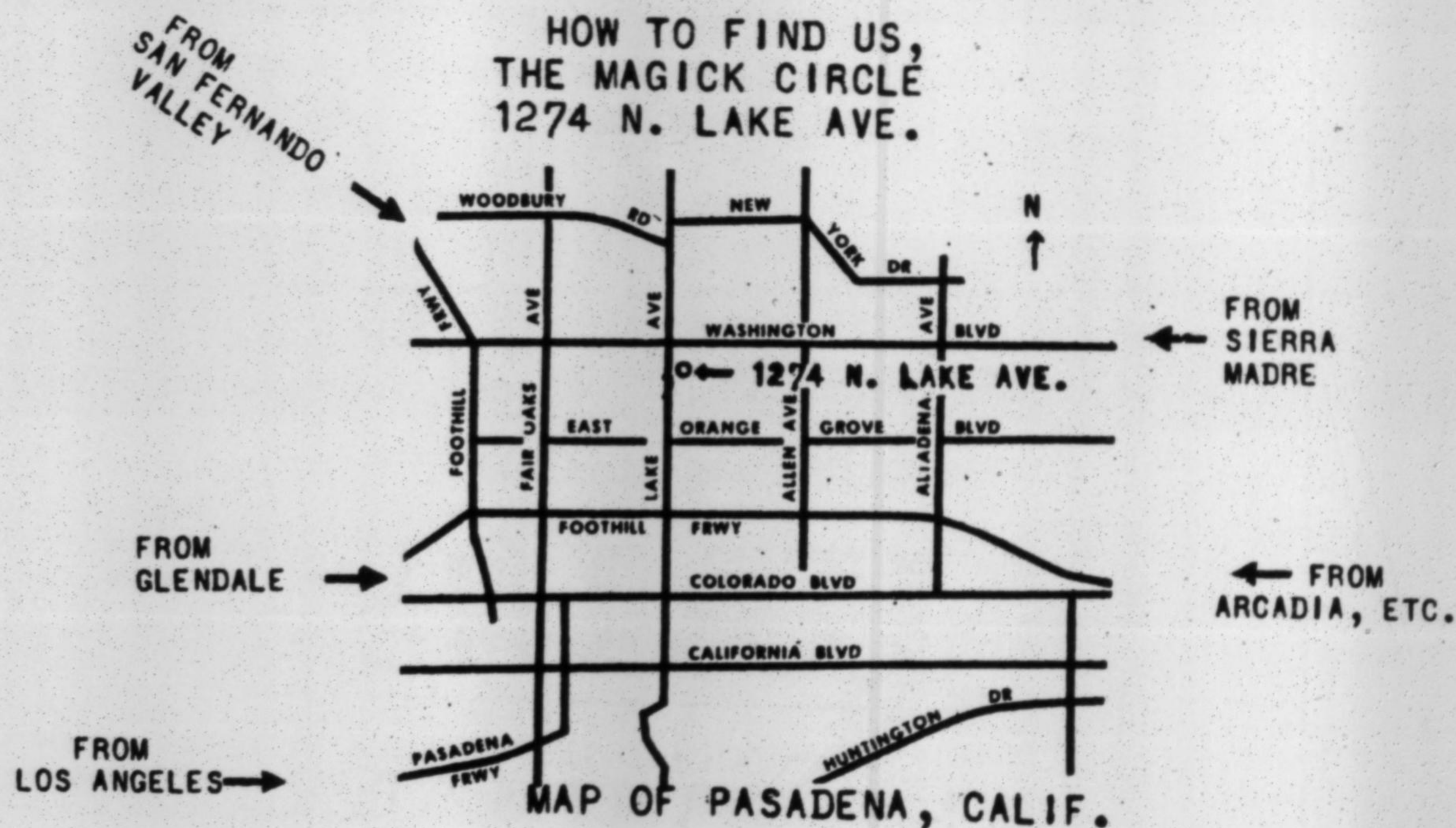

# The Temple of Truth

**THE TEMPLE OF TRUTH**, unlike most other Orders and Magickal Lodges, is essentially *unstructured*. It has no "grades," issues no pretentious certificates, and has no fixed curriculum. The Temple of Truth exists primarily for its students and members, and hence does not get involved in the internal workings of other organizations. The Temple of Truth takes no part in political quarrels which sweep through the contemporary American Occult scene. Likewise, we abjure most of the "traditional" secrecy which all too frequently hides ineptitude and selfishness on the part of those purporting to know it all. What little is kept secret is simply for the safety of the individual student, and no information is "forever denied" to a promising student. Each individual is free to select his own course of study, as well as the rate at which he chooses to pursue it. This "independent study" concept allows the staff as well as the students considerable flexibility. The student defines what it is he wishes to do and then later submits a report on the results he has achieved. Selections from these reports may be published at a later date.

Individual students are encouraged to adopt the scholastic method but not required to do so. In any event, the lack of rigor will not bar the student from opportunities to test his theories. Empirical results are the cornerstones of the student's progress.

Flexibility is also stressed in the admission standards of the organization, the main emphasis being on a better than average moral and ethical behaviour on the part of the individual applicant. The applicant's motivation should be a desire for spiritual development rather than an egotistic craving to

be called a "High Priest" or a "High Priestess," or the lust for "Powers"—usually over others—in lieu of Self-control.

The student is encouraged to practice his magick in his own home as a part of his everyday life. This emphasis on individual practice (after an initial period of instruction) is one of the largest differences between The Temple of Truth, and other Magickal organizations operating in the present Occult spectrum. Membership in The Temple of Truth is non-exclusive, or in other words, members of other organizations can join ours. Dues are low because we are not supporting a large staff or headquarters complex.

The Temple of Truth is sponsored by The Light of Truth Church, a duly licensed and incorporated Religious Institution. The Church is neither evangelistic nor fundamentalist in the usual sense. We do proselytize the basic dignity of Man, and we recognize the subjectivity of what most people call "truth." The Church's teachings, being cabalistic, are compatible with Christian, Moslem, and Hebrew religious tenets.

Dues, donations, and so forth to either the Temple or the Church are entirely tax-exempt, under both State and Federal law.

The Church also operates a Gift and Occult Supply shop, The Magick Circle, at 1274 N. Lake Ave., Pasadena, California.

# The Temple of Truth

**THE TEMPLE OF TRUTH**, unlike most other Orders and Magickal Lodges, is essentially *unstructured*. It has no "grades," issues no pretentious certificates, and has no fixed curriculum. The Temple of Truth exists primarily for its students and members, and hence does not get involved in the internal workings of other organizations. The Temple of Truth takes no part in political quarrels which sweep through the contemporary American Occult scene. Likewise, we abjure most of the "traditional" secrecy which all too frequently hides ineptitude and selfishness on the part of those purporting to know it all. What little is kept secret is simply for the safety of the individual student, and no information is "forever denied" to a promising student. Each individual is free to select his own course of study, as well as the rate at which he chooses to pursue it. This "independent study" concept allows the staff as well as the students considerable flexibility. The student defines what it is he wishes to do and then later submits a report on the results he has achieved. Selections from these reports may be published at a later date.

Individual students are encouraged to adopt the scholastic method but not required to do so. In any event, the lack of rigor will not bar the student from opportunities to test his theories. Empirical results are the cornerstones of the student's progress.

Flexibility is also stressed in the admission standards of the organization, the main emphasis being on a better than average moral and ethical behaviour on the part of the individual applicant. The applicant's motivation should be a desire for spiritual development rather than an egotistic craving to

be called a "High Priest" or a "High Priestess," or the lust for "Powers"—usually over others—in lieu of Self-control.

The student is encouraged to practice his magick in his own home as a part of his everyday life. This emphasis on individual practice (after an initial period of instruction) is one of the largest differences between The Temple of Truth, and other Magickal organizations operating in the present Occult spectrum. Membership in The Temple of Truth is non-exclusive, or in other words, members of other organizations can join ours. Dues are low because we are not supporting a large staff or headquarters complex.

The Temple of Truth is sponsored by The Light of Truth Church, a duly licensed and incorporated Religious Institution. The Church is neither evangelistic nor fundamentalist in the usual sense. We do proselytize the basic dignity of Man, and we recognize the subjectivity of what most people call "truth." The Church's teachings, being cabalistic, are compatible with Christian, Moslem, and Hebrew religious tenets.

Dues, donations, and so forth to either the Temple or the Church are entirely tax-exempt, under both State and Federal law.

The Church also operates a Gift and Occult Supply shop, The Magick Circle, at 1274 N. Lake Ave., Pasadena, California.

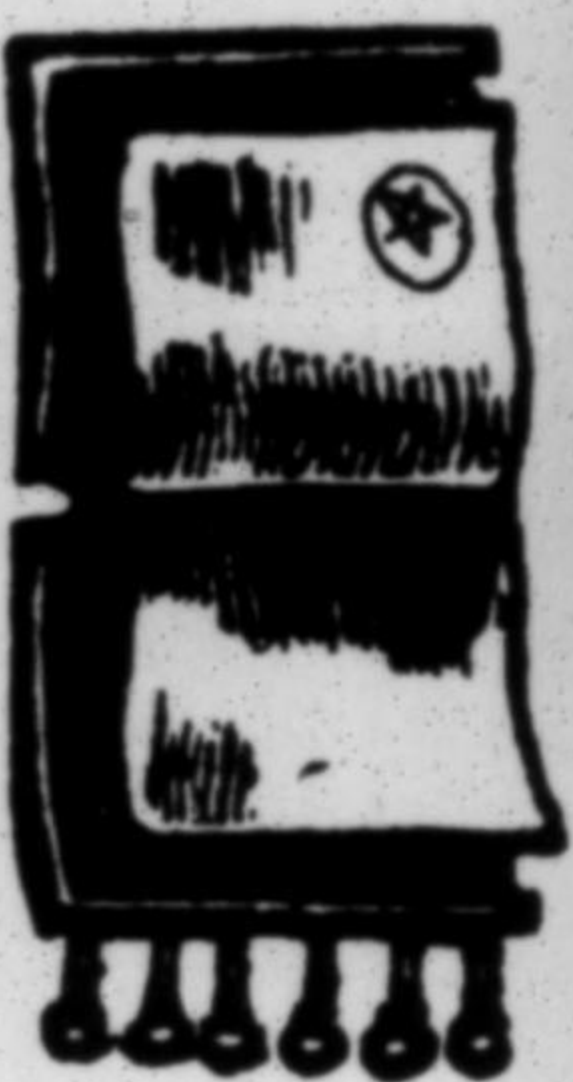

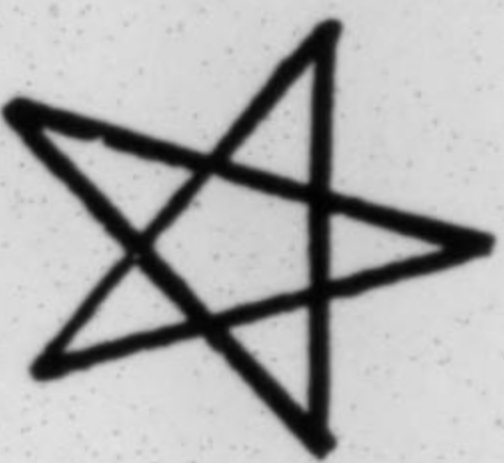

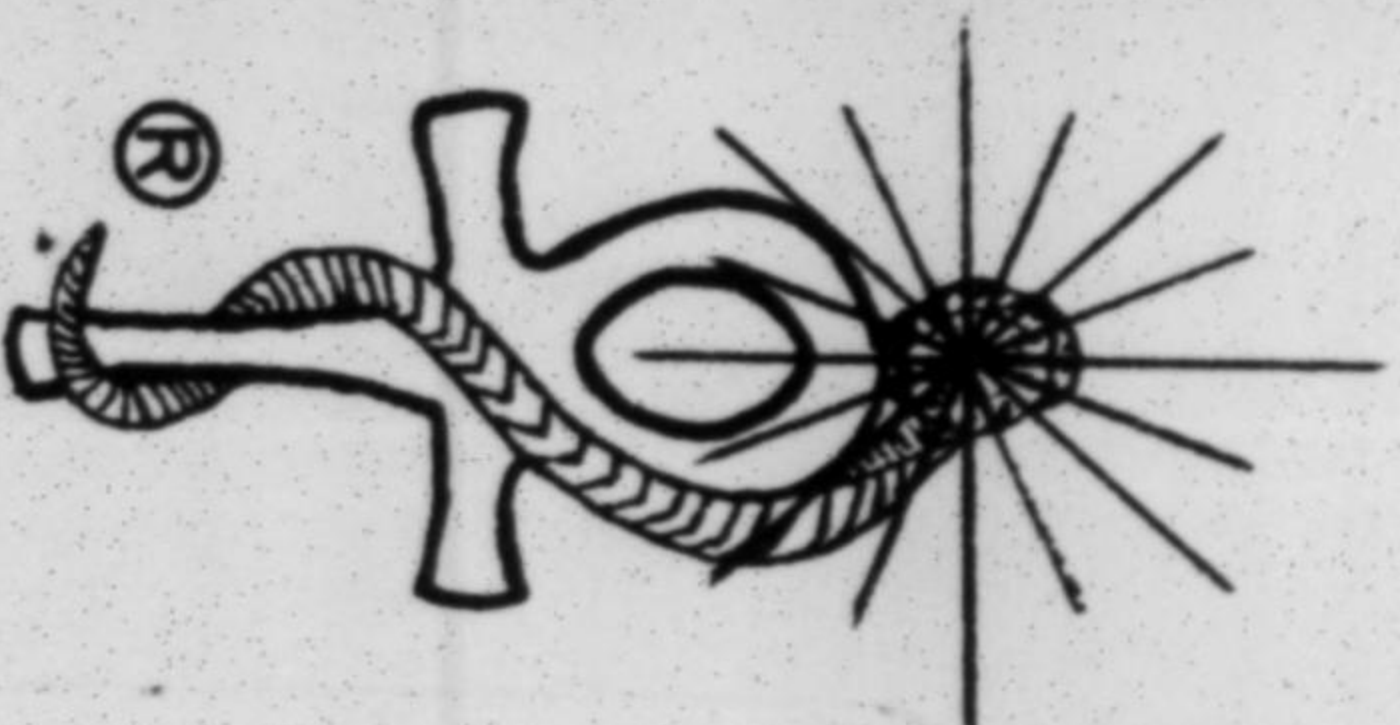
