## **Breathing Light/ Breathing Time**

# original concepts in this paper are the intellectual property of the author:

A practical analogy can be made between the process of respiration in plants and animals (oxidation/reduction or "redox") and the transduction of the "aetheric" (traditional nomenclature) and "traction fluidice" energies¹ with the material continuum. A literal, mechanical model is presented in this paper which will both account for observed instances of energy/information intake/depletion and may also provide a basis for designing equipment which can facilitate this process.

In this context, the mysterious "implants", "abscesses" and "miraculous healings" experienced by spiritualists and "ufo contactees" can be seen as a function of nano energy respiration through the living tissue itself. These may be naturally-occurring mind/matter effects caused by the mind of the person experiencing the effects or by a linking with another mind or discarnate intelligence.

A description is also given of how a hypothetical "implant" might work to jump start mind/matter effects via artificial induction of electro-chemical neural transduction via the "fluidice matrix" system associated with an acoustic nano tubule.

:Literal vampirism is also discussed in context of these concepts of artificial activation of life energies in neural networks as is the "breathing" of "prana" in yoga tradition. The possibility —as in ancient traditions—that stones, crystals and other non-organic substances also "breathe light" in terms of "fluidice matrix" transduction will also be discussed in this paper.

This inbreathing of fluidice energy substance can also account for effects such as candle flames which elongate and smoke during a séance or softening and bending of metal during a "spoon bending party". But this is a catalytic effect rather than a phlogiston-like circulation of an additional,

palpable elemental substance. The analogy employed in this discussion is with inner heat and/or sound not with exterior "aether" as an additional, material substance. The catalyst affects electromagnetic structuring as a chemical catalyst affects ionic balance during oxidation/ reduction and other electrochemical processes.

Each instant the nano catalyst "breathes" i.e. "shifts structural frequency" there is a slight alteration in mass-time simply by virtue of the shift in coherent atomic pulsation. This effect is often noticed within certain geo-areas—some of these very small—within which time anomaly and "spirit" or "ufo" effects are reported. There has been some confusion in the minds of people reading and reacting to the previous papers on the "fluidice matrix" concept about the meaning of the word "pattern" or "patterning" as applied to the effects of reflexive time transduction. In this paper it is made clear that the patterning inducted into the atomic structuring by the nano shift caused by "traction fluidice" is "breathed into" the coherent structuring of space time as a woven fabric may expand, stretch or shrink by catalytic action of water, steam or similar and is not molded into the electromagnetic tissue by mechanical force. The mechanical effect or kinetic force in the situation results from coherent nano transduction. This is true also of the use of feng shui and sympathetic magick.


The structure of spacetime breathes patterns into existence as a seed grows innately, changing form many times before achieving mature manifestation. Yet this change may occur instantaneously. One might contemplate the enigma: "How does the seed "know" how to develop?" in terms of observed instantaneous shifts of destiny and material form. Photos on which unexpected images appear will be shown in this context.

#### DISCUSSION

Since we are within the body and accustomed to think and act within the body, functional RV/PK/ ESP systems should also be based within a systemic paradigm which naturally includes the physical, material continuum. It is when psi enthusiasts eschew the body that they enter rough waters. Inclusion of the material PROCESS is part of all religious rituals. Going Out of the Body (OOB) conceptually requires a body to exit from and a bridge back to that body unless death is intended.

As the eye adjusts to light by spontaneous expansion/ contraction of the retina, so the mind/body chackra (traction fluidice) transduction system spontaneously enacts idea/form. Secondary scenarios may thus be enacted which have the physical/mental impact of primary scenarios, causing by a process of feedback a full interdimensional involvement including the material dimension.


Figure one: Simple "Premonition" Diagram



So that the premonition of a car accident (as one example) which never happens because of action due to mental activity is transmitted via the brain/ body mechanism to cause an "escape" which follows and/or parallels the possible situation of a material accident. Thus the premonition causes the escape via the idea that there has been an accident or that an accident is possible. This idea may also enter subconsciously, causing evasive behavior which may seem irrational. Unless the future accident is cognized "escape" is not part of a future which is not expected to contain an accident. The escape by avoidance or subliminally activated luck contains the accident itself as an alternate or parallel destiny timeline. These possible linear timelines are acted upon a-sequentially by a "5th dimension" of "reflexive time" which receives and stores for coding in a (6+n)-dimensional matrix the 4-dimensional linear possibilities as quaisi-"holographic" coding. How does this happen? The dilating transduction chackra (DTC) must have a "frame" of stasis for manifestation in the familiar 4 dimensions associated with electromagnetic mass structure.. The human body provides such a sensory frame within the brain/body neural system. It can be understood, for example, that sea creatures at great depth are providing a different sensory perceptual mechanism for the DTC frame. Therefore the "frame" of the undersea-based DTC will permit an analogous transduced image/impression which has a


similar meaning to the land-based DTC images permitted by the human brain/body neural frame. However, the situation of some type of DTC opening/closing remains a constant in all living tissue..

"Neural" is understood in this situation as electro-chemical signaling. Artificial DTC would need such electro-chemical transduction synapses. This would be a tissue sponge of nano wormholes within and pervaded by a "fluid force" energy.

squeezing/expanding simultaneously within the atomic fabric and not the "microscopic wormholes" of recent quantum physics speculation. This innate creation of additional density boundaries which present refractive surfaces can account for certain anomalous effects in areas bounded by varying gravitational mass frequency indices which cause kinetic electromagnetic refraction . This is a different conceptual model than tornado or solenoid type "special large corridors" as dimensional gateways. This model involves a pervasive additional force/energy fluid which simultaneously saturates the nano "wormhole sponge" via quaisi-holographic process with the force/energy fluid already permeating the nano "wormhole sponge".

The concept of "k" as quantized mass density analogous to variable kinetic stress is presented in papers describing the "fluidice matrix" concept. Here equations included in a "fluidice matrix" paper in 2002 and posted on the web at http:// fluidice.com/sync.html are once again employed to describe "electromagnetic refraction". The following equations use a simplified version of the familiar Einstein mass/ energy equivalence concept with the situation of varying local density added via the concept of "traction fluidice" as a coherent "fluid-force" which can alter the Planck index of nano mass areas locally.

The government of Canada has done extensive surveying and study of gravitational anomalies in Northeastern Quebec and off the coast of Nova Scotia. An article in the May 11, 2007 journal *Science*<sup>2</sup> details the findings of one Canadian research group which discovered an altered mass density in the Hudson Bay area which they attribute to glacial pressure during a previous ice age. According to the Canadian analysis, this compression of the geo-area has affected the gravitational index in the area, causing the oft-reported instances of gravitational anomaly. According to the news report, the report in *Science* also quite accurately states that this pressure which once altered the mass density of the geo-area is not the entire explanation of the situation, which is not yet completely known.

It is appropriate to add here that the effects reported in Northeast Canada and the so-called "Great Lakes Triangle" area are also of time anomaly and alleged ufo activity, as well as instantaneous appearance and disappearance of objects, apparitions and so forth.<sup>3</sup>


A discussion of the magnetic field of the Hudson Bay geo-area is not featured in the recent flurry of news related to the Canadian report, which focuses mainly on gravitation. Magnetic anomalies will be discussed later in this paper.

#### EXPERIMENTAL JOURNEY

On an expedition in 2005 to an area of upstate New York where a goodly share of apparitions, ufos, visions and hauntings have been reported a photo of what appears to be "orbs" and an inverted crucifix or upraised sword upon a tree trunk with an upright crucifix of light to the left of the tree image was taken with a digital camera at an intersection beside a currently unused grade school situated

opposite a plaque placed by a local historical society which marks the location of original settlers in the area several centuries ago.

There was no particular plan to photograph this intersection. It simply "felt" like the right place to take a picture. There is no local legend of the supernatural attached to this place. But if the effects have been negative or frightening such tales may not have been included in the standard historical tour.

One can make standard physics and engineering models of "wormholes" as a type of solenoid, a variation of the three-dimensional electromagnetic wire wrapped about a zero value acoustic cylinder space but this type of model does not explain instantaneous appearance/disappearance of areas of mass (such as the image on the crossroads sword photo) within coherent three dimensional structuring. That such appearances "pop out of a rabbit hole" is unlikely. It is more likely that available electromagnetic mass fabric is transformed by a process not fully understood and part of the active function of the mind's link to the structural logos of mass. In general, there is difficulty in understanding this additional "force" or energy within the warp / woof of nano mass structure which counterpoints and patterns the material electromagentics which we are able to perceive by use of strictly electromagnetic detection equipment. Our observation and recording of this additional component of mass is limited by both the conceptual and physical equipment we are accustomed to use.

The "torsion fields" designed by certain theorists attempting to adapt a description of this process to strictly electromagnetic "quantum" systems now in use approximate an understanding of this structural "molding" process but are bound in detail to a binary view of mass structure. This is because the unknown structural force in the warp/woof of the mass matrix is conceptualized as a

reverse template image of systems developed to utilize the electromagnetic nature of mass only. In order to adequately understand the action of materialization/ dematerialization, it is necessary to realize the existence of a non-binary acoustic force. This force has been described in the early "fluidice matrix" formulations as quaisi-magnetic in effect, acting on the magnetic vector of the electromagnetic mass assembly, as has also been noticed by Dr. Michael Persinger<sup>4</sup> and others.<sup>5</sup>


The reason equipment designed by Dr. Persinger has failed to replicate effects in experiments not run by Dr. Persinger himself is simply because the logos field is not actually a magnetic field but is quaisimagnetic, rearranging mass structure by a process more like oxidation/reduction (breathing-ionic mass rearrangement) than photon or electron bombardment.

In other words, a quaisi- "holographic" element of structuring attaches to the electromagnetic nano mass as an ion attaches or detaches during the oxidation process, transforming the original configuration by catalytic action. Since Dr. Persinger was a part of the complete structuring of the holographic fluid-force field attached to his use of a special "helmet" to enhance perception, his deliberate absence from independent use of the same design and protocol will affect the use of the helmet device, particularly when independent testing may focus on material construction rather than the more subtle quaisi-magnetic and gravitational fields which also interest Dr. Persinger.

A concept and/or protocol can be similar to a 3d device with the functional link to the three dimensions of "visible" mass occurring in the area of time. (See the "premonition diagram" given earlier in this paper) "Time" can be understood both as a registry of 4d change and as a frequency gauge for the nano mass structure. The process of mentally activating a conceptual model triggers neural/chemical signaling, which is electromagnetic. So also (by action of the quaisi- "holographic" structural energy) this mental process can directly affect the nano-structure of matter. This is also true of the larger patternings of the quaisi-"holographic" structural energies in actualizing 4d effects. The Parsi philosophy has for centuries compared the development of events to the growth of a seed, which contains the pattern within of the adult plant it will become. It is the "holographic" situation which triggers realization of this process not solely the electromagnetic and/or gravitational state of the brain/body system of the conscious operator. Why then do certain geo-areas such as Hessdalen in Norway seem to have more catalytic energy per cubic centimeter? It seems that actualization of these effects may require an "anchor space" or "frame" as previously discussed in context of the organic body as the site of multidimensional transduction.

The "anchor" is the electromagnetic vector. Without this anchor, the "holographic" structural energy / force can be somewhat of a loose cannon , manifesting erratically. So when the mass density of a bounded area is different from adjacent, surrounding areas, the larger structure is more able to be "pushed" by this nano area of altered density, as when a balloon floats in mid-air or a vessel filled with air or gas floats on water, displacing and/or colliding with the molecular fabric which supports the package of differing density.

The "additional surfaces" created by a difference of mass density indices may be what we see when an apparition partly materializes, as if a force-fluid creating a differing density could use existing molecular structure to saturate kinetically a nano area, expanding the sponge of nano wormholes by a live structural energy blueprint which runs nano force-fluid mass adjustment like a cyber installation according to a data program.

What are these "holographic" structural energy blueprints? Is this energy a living energy in the sense that the organizational energy of a living body is "alive" and co-ordinates autonomic processes until "death" when the material structure of the body loses central organization and decomposes? In Hindu tradition, the "devas" or nature spirits animate and own various functional areas of the earth . These are the "nature spirits" and "messengers of the gods" in folk traditions

worldwide.

On one photo taken by an assistant "tourist" near the site of the "sword-marked" tree in upstate New York previously shown in this paper, an unusual symbol appears on the chest area of E. Macer-Story's dress. The meaning of this symbol is not known to this author and it is difficult to describe the symbol verbally. It looks like a "greater than" mathematical symbol preceded by a dot. Or possibly this symbolic transmission represents a living cell or amoeboid organism.

Also included in the larger "tourist" photo is a large teepee-shaped arrangement of sticks and branches found beside the road. The purpose of this roadside stick cairn is unknown to this author. One might speculate on a Native American origin but similar stick cairns are found all over the world and the same teepee-shaped marker might originate in a number of different traditions, as the historical marker down the road clearly indicates. But the fact of the teepee marker does indicate that some individual and/ or interest group also appreciates the special quality of this area where numerous "ufos" and apparitions have been reported for centuries.

#### CONCLUSION

It might be possible to take such a "multidimensional transduction area" along with the individual. In order to accomplish this enhanced receptivity to "holographic" activation the situation of an area of altered nano mass density embedded within a larger geo area might need to be duplicated. The "implants" claimed by certain ufo contactees<sup>6</sup> might simply be a catalytic data transmission enhancer of a differing nano force/fluid density placed within an environment of coherent, living tissue in order to facilitate communication.

The symbol shown on the cotton tee shirt type fabric above—for example—could be some ancient language but it could also signify in mathematical context "greater than a single dimension". The symbol occurs over the mid-chest area which contains the heart and respiratory systems and where, in Hindu terminology, the heart chackra near the solar plexus neural center is located. This symbol seems to be overlaid on the photo image of the fabric without distorting the patterning already in the

fabric. Thus also the subtle process described within this paper takes place **within** the already observed e/m mass structure.

We know that if we do not intake enough oxygen, which is then catalyzed in the presence of hemoglobin by electron transfer, our bodies will die. <sup>7</sup> Similarly, in photosynthesis the catalytic presence of chlorophyll converts the energy of solar radiation containing ultraviolet frequencies into useable chemical energy, releasing oxygen and sugar by combining water with carbon dioxide. <sup>8</sup> As described in the previous section of this paper about "additional surfaces", the quasi-magnetic structural "fluid-force" or energy may act as a catalyst within mass structure to cause literal nano and thus atomic shifts which facilitate by quaisi- redox ion transfer both such effects as coherent anomalous images appearing on photos and the unusual, observed time qualities of certain geo areas manifesting anomalous phenomena. For the time index of linked molecular pulsing is different within the bounded mass area altered by the fluid/ force field. In the micro-chemical reactions, the *structure of the molecule* literally changes and this structural change is kinetic, as in the analogy with the expansion/ contraction of the retina given earlier in this paper.

The key to understanding these possibilities is the presence of the structural quaisi-"holographic" fluid/force substance *within matter* on the atomic, nano level in the same way (by analogy) hemoglobin is present in the blood and chlorophyll in plant tissue. This situation occurs throughout electromagnetic mass structure. If there is a local blockage in this structural logos transduction patterning, an "abcess" may occur in the organic mass fabric as when anemia occurs due to hemoglobin depletion or plants wither in the absence of ultraviolet radiation. Perhaps these concepts could be applied on the cellular and molecular levels in studying cancer and viral infections. For this structural fluid/force catalyst is evidently the quaisi-"holographic" repair system employed by healers and shamans.

- 7) Hemoglobin is a protein-based component of red blood cells which is primarily responsible for transferring oxygen from the lungs to the rest of the body. Hemoglobin is actually the reason red blood cells appear red, although oxygen-rich blood is noticeably brighter than the depleted blood returning to the heart and lungs. Fresh hemoglobin is produced in the bone marrow as needed. The creation of hemoglobin is controlled by a complicated genetic code. Because unborn babies obtain their oxygenated blood from their mothers and not their own lungs, two separate substances called hemoglobin alpha and hemoglobin gamma combine with several nitrogen atoms and one iron atom. This allows the fetus to receive oxygen-rich blood without respiration. Once the infant is born, however, the body replaces hemoglobin gamma with a new variant called hemoglobin beta. The combination of these two substances continues for a lifetime. Essentially, hemoglobin develops a hunger for oxygen molecules. When the blood is carried into the lungs, hemoglobin proteins containing iron atoms attract whatever oxygen is available. This oxygenated blood then travels throughout the entire bloodstream, releasing oxygen into the muscles and organs. The spent red blood cells are transferred to the gastrointestinal system for disposal and new red blood cells with hemoglobin take their place in the bloods
- 8) <u>Photosynthesis</u> is the process by which plants, some bacteria, and some protistans use the energy from sunlight to produce sugar, which <u>cellular respiration</u> converts into <u>ATP</u>, the "fuel" used by all living things.
